MELISSA ARULAPPAN NATIONAL VICE-PRESIDENT ASH COUNCIL


- Melissa Arulappan has spent over three decades in challenging and exciting communication roles in the corporate and consultancy sector in India.

- Currently, she works with BRK Law Partners on commercial contracts and transactional matters, and advice and support start ups.




DEEKSHA MEHTA WAHI
