




(RITIKA SHARMA) VICE PRESIDENT, MEDIATION AND DISPUTE RESOLUTION COUNCIL WICCI

I am hardworking, determined and punctual towards my work and also possess good speaking skills.





She did an internship in Delhi Commission for Child's Right Protection, Think India, District








(KHILANSHA MUKHIJA) COUNCIL MEMBER, MEDIATION AND DISPUTE RESOLUTION COUNCIL WICCI




(DIVYA KARDA) COUNCIL MEMBER, MEDIATION AND DISPUTE RESOLUTION COUNCIL WICCI




(DISHA PANCHAL) COUNCIL MEMBER, MEDIATION AND DISPUTE RESOLUTION COUNCIL






