She is also one of the advocates empanelled on the board of District legal Services Author






Adv. Bani Mahajan




Ms. Niharika Grover

Adv. Varanpreet Kaur


COUNCIL MEMBER, WICCI N.R.I COUNCIL (U.T Chandigarh)

COUNCIL MEMBER, WICCI N.R.I COUNCIL (U.T Chandigarh)




Adv. Chinansha Aggarwal
