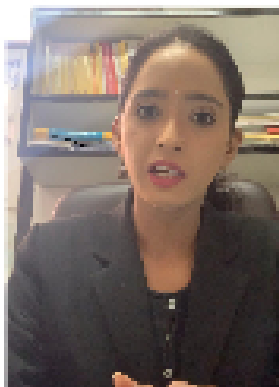
Adv. Swati Mehra

She is an advocate. Also she has experience in teaching as she has worked as Professor in CLS, Gibs, GGSIPU.



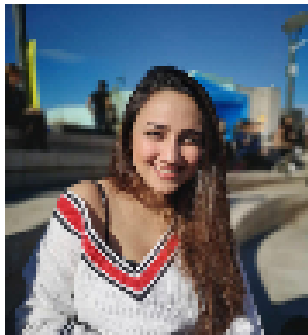
Ms. Sumita Shibanee Sahu
