The implementation and effectiveness of Corporate Governance can be felt only if appropriate, competent and skillful directors are appointed to the board. "Is one women representation enough to have a competent Board?" Although there are pools of good womentalent, we see that large companies still don't have women on Board. DCGC's mission is to inspire visionary boards worldwide – by providing education and tools that keep members engaged, informed, and high-performing as individual women directors.






#### Amiesha Dhall, Council Member RESEARCH DEPARTMENT, DELHI CORPORATE GOVERNANCE COUNCIL WICCI



### Alfi Shibu, Council Member RESEARCH DEPARTMENT, DELHI CORPORATE GOVERNANCE COUNCIL WICCI








### Chavi Dusad, Council Member FINANCE DEPARTMENT, DELHI CORPORATE GOVERNANCE COUNCIL WICCI






### Navya Arora, Council Member FINANCE DEPARTMENT, DELHI CORPORATE GOVERNANCE COUNCIL WICCI
