Her area of interest is women rights and child rights.


She is Ph. D. in Law and currently working with Amity University Uttar Pradesh.






MS. AKANKSHA SINGH, COUNCIL MEMBER, DELHI WOMEN LAWS IN INDIA COUNCIL, WICCI




