Dr. Tara Chothani, COUNCIL MEMBER, GUJARAT INTELLECTUAL PROPERTY COUNCIL, WICCI



Lalita Chothani, COUNCIL MEMBER, GUJARAT INTELLECTUAL PROPERTY COUNCIL, WICCI



Vidhi Thakker, COUNCIL MEMBER, GUJARAT INTELLECTUAL PROPERTY COUNCIL, WICCI



Shreya Sathe, COUNCIL MEMBER, GUJARAT INTELLECTUAL PROPERTY COUNCIL, WICCI


Shreya, has completed B.Tech in textile technology. She is working in b2b industry and having a 7+ years of experience. She loves to play tennis.

Rewa Sharma, COUNCIL MEMBER, GUJARAT INTELLECTUAL PROPERTY COUNCIL, WICCI


