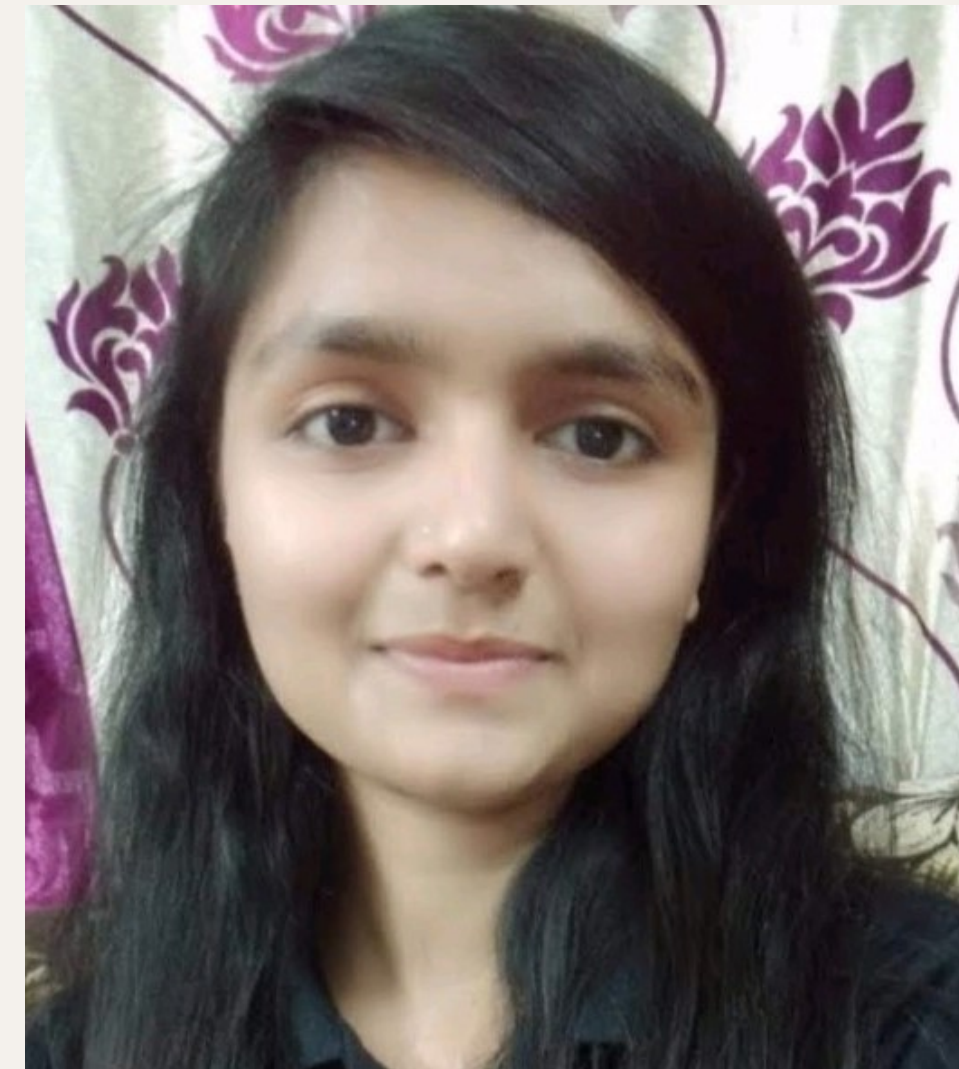


# MANALI AGRAWAL- COUNCIL MEMBER
